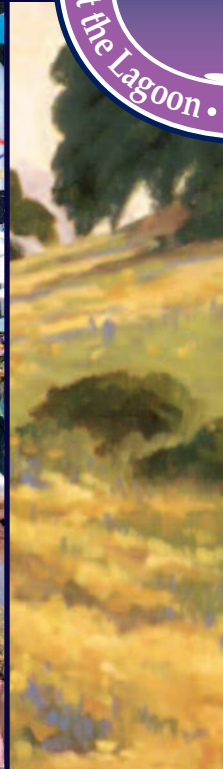

An application is provided on the back of this Call for Artists. This is a juried art festival. The selection of artists takes place in early March.

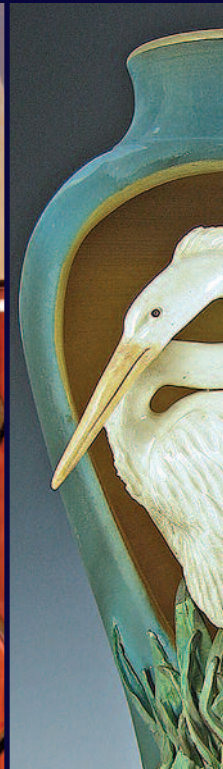

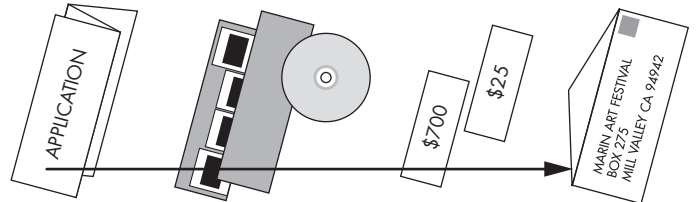

Instructions Send four images of current work with your payment – either slides or CD (minimum 3.3" along any edge at 300 dpi), put name on each slide. Location requests are honored in the order they are received.



Space Fee is \$700, this includes canopy.

Jury Fee is \$25.

Jury meets monthly to select early applications. All four images are viewed simultaneously.

Application Deadline April 1, 2012.

Location Lagoon Park, in the Marin Civic Center (Frank Lloyd Wright).

Exhibitors Painters, sculptors and fine crafts. Artist must be present.

Multiple Media Submit four slides or photo CD for each media.

Slides are used for promotion and cannot be returned.

Postcards supplied free to the artists.

Booths 10x10, all corners with canopy.

Spill Please spill out 3-4 feet outside your booth.

Sculpture Courts are by the Lagoon & inside courtyards.

Access You can drive to the booths for setup and wrap-up each day.

Rentals The Festival will rent Umbrellas, Chairs, Tables, and Panels, and have them delivered to the artists booths before the event.

Participation Implies permission to use images of artwork and artist in promoting the event.

Artists May Share Space with another accepted artist.

Withdrawals are accepted up to March 15 for a full refund. Up to May 1 for a half refund. After May 1 funds will have been committed.

Wait List will be held subsequent to available space.

Artist Free Parking adjacent to the festival.

Sit-down Dining is available in the main pavilion.

Security Friday evening through Sunday evening.

Entertainment Music and dance.

Promotion The event is publicized in newspapers and radio throughout the Bay Area and draws patrons from as far as 100 miles away.

Additional Licenses, Fees, and Permits. None.

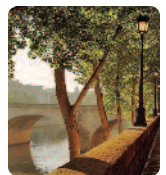
